Camp Zama Pet Kennels Grooming Rules and Regulations

1. ___ Grooming services are by reserved appointment. Dogs will undergo a physical/wellness check prior to admission. Owners will be called once their dog's grooming appointment is finished and pick up must be within 30 minutes from the time of contact. Services are considered complete upon payment. If you are not happy with something regarding your dog's grooming – please inform our staff of the issue and we will rectify it on sight. Service requests after appointments will be treated as separate services to include additional fees.
2. ___ Dogs are in good health, with no active vomiting, diarrhea, parasites, with proof of up to date Rabies, Distemper Combo, and Bordetella vaccines. Dogs cannot be groomed if they show signs of illness.
3. ___ If any dog is found to be too aggressive, difficult, or uncontrollable the owner will be called. Services may be partially given or not at all in these cases.
4. ___ If you give no notice of cancellation / fail to show for your grooming appointment there will be a \$30 no-contact fee added to your account that must be paid prior to making another reservation. Two missed appointments will result in further actions.
5. ___ Dogs presenting with undercoat mats will be shaved as brushing these types of mats is time consuming, painful, and strenuous. Ensure pets are properly brushed the night prior to grooming. Additional charges for severe matting, parasites, or poor pet condition may incur at the discretion of our groomer.
6. ___ Dogs may become unusually distressed or upset for a variety of reasons in a multiple animal environment, even if previous visits have been uneventful. If a pet is showing signs of significant elevated stress the grooming appointment will be rescheduled for a later date.
7. ___ If you are wanting a specific, specialized, or unusual style request we kindly ask for clear picture representations on what you are looking for and our grooming staff will do their best to accommodate this.

I **DO / DO NOT** give permission for the Camp Zama Pet Kennels Staff to take, save, and use pictures, photos, or videos of my pet during their grooming sessions for examples, promotions, or other potential outlets.
